

What is Human Trafficking?

It can be defined as the recruitment, harboring, transportation, provision, or obtaining of a person for labor or services using force, fraud, or coercion for the purpose of involuntary servitude, peonage, debt bondage, or slavery. This occurs in situations of forced labor such as domestic servitude, factory, or agricultural work.

JANUARY HIGHLIGHTS

2023 January Outreach: GCASAFV in collaboration with the Bureau of Women's Affairs

On Saturday, January 21, GCASAFV, in collaboration with the Bureau of Women's Affairs and the Governor's Community Outreach Federal Programs Office, held a Community Outreach with partners to recognize January as National Stalking Awareness Month as well as National Slavery and Human Trafficking Prevention Month at the Micronesia Mall.

Stalking is an important issue to bring awareness in our community considering many people are unaware of what may be considered reportable. According to the most recent statistics from Guam Police Department, there were 86 reported cases in 2021 that included incidents of stalking. GCASAFV continues to raise awareness on issues of Stalking so that our community can recognize the signs and put an end to stalking on the island.

January 11th marks National Human Trafficking Awareness Day, a time to call attention to this persistent crime that occurs worldwide. Although Guam lacks any reportable statistics on Human Trafficking, it is important to recognize that this is a reality for some individuals in our community and continue to raise awareness on the available resources to victims.

Governor Lou Leon Guerrero signed a Proclamation to recognize January as National Stalking Awareness Month as well as National Slavery and Human Trafficking Prevention Month. Speaker Therese Terlaje, accompanied by Senator Amanda Shelton and Senator Will Parkinson, presented the Legislative Resolution, indicating the importance of raising awareness on Stalking and Human Trafficking, and commending all the service providers who assist victims seeking services.

This is the time of year that many grant opportunities become available. The Office on Violence Against Women (OVW) has recently posted several announcements on its website that may be of interest to you. Here are a few tips to keep in mind as you consider applying for these grants:

- You will need your Unique Entity Identifiers (UEI) number and be registered with the System of Award Management (SAM) and on Grants.gov (https://www.grants.gov) by the date posted in the solicitation.
- Review the solicitation and list all the 'must' and submittal requirements for any grant your organization
 wishes to apply for. Tip: Submit the forms as soon as possible once your organization has decided to apply
 for the grant to avoid missing the deadline, and so there will be ample time to address any technologyrelated issues if they arise.

OVW Fiscal Year 2023 Legal Assistance for Victims - Solicitation (O-OVW-2023-171479)

The Legal Assistance for Victims (LAV) Grant Program is intended to increase the availability of civil and criminal legal assistance needed to effectively aid adult and youth (ages 11 to 24) victims of domestic violence, dating violence, stalking, or sexual assault by providing funds for comprehensive direct legal services to victims in legal matters relating to or arising out of that abuse or violence.

The goal of the Disability Grant Program is to create sustainable change within and between organizations that improves the response to individuals with disabilities and Deaf individuals who are victims of domestic violence, dating violence, sexual assault, and stalking, and to hold perpetrators of such crimes accountable. THE MORE YOU KNOW



Community Champion: Transforming Ourselves through Healing Growth & Enrichment (TOHGE)

TOHGE (pronounced TOE-gi) Guam; is The Guåhan Peer Support Cultivation Foundation. They are a Recovery Community Organization that provides Peer Support Services for those who continue to struggle with mental health and/or substance use disorders. In the Chamorro language Tohge means; to stand or rise up. TOHGE is an acronym as well who's mission statement is: The establishment of a sustainable territory-wide network of empowered peers by; Transforming Ourselves through Healing Growth & Enrichment and was established on May 22, 2017.

The purpose of TOHGE is to be able to provide Peer Support Services for other peers through their own lived experiences. All members of TOHGE Guam have managed to find their own pathway to recovery from issues with mental health, substance abuse, and some from both (co-occurring disorders). They have accepted personal responsibility for their own issues, managed themselves, and become self-sufficient; enough for them so that they can work with others that face the same issues as they once did.

By facilitating self-advocacy and self-efficacy, TOHGE empowers everyone to find their voices in their own recovery process. They allow peers to explore their own options, with what their recovery should look like to them. They allow them to take their own direction down their pathway as they walk alongside them. They work with them where they stand in their recovery, and take a person driven approach, focusing on the peer in recovery strengths, and promote independence.

TOHGE came about through a police academy grant by SAMSHA which was obtained by Guam Behavioral Health and Wellness Center by the late Don Sabang who was a former Supervisor of Drug and Alcohol Division. This grant encompassed getting stake holders in the community together to determine where the gaps in services where and how it could be supported. Through a feasibility study executed by Dr. Debbie Ellen (University of Guam) it was determined that the community needed a Peer Run Organization where peers who had successfully recovered and become certified peer support specialist would offer peer support services to other peers in treatment. After the tragic passing of Mr. Sabang, Athena Duenas, Supervisor of Drug & Alcohol Division (New Beginnings), would then support and guide the development of the nonprofit to what it is today. The initial peers to volunteer and dedicate their time benevolently to support the organization were Dean Toves, Garret Duenas, Jeremiah Santos, and Brad Drake II. They began by utilizing a "grass roots approach" by building awareness in the community and fostering hope that one could recover from addiction and behavior health challenges.

As one of the three subgrantees of the Allstate Moving Ahead grant, TOHGE has established its economic empowerment support training services project called the **TAKE CHARGE PROJECT.** This project is designed to assist domestic violence survivors achieve financial independence and rebuild their lives. With this project, TOGHE plans to utilize the Allstate's Moving Ahead Curriculum to facilitate trainings on the curriculum for survivors to promote financial empowerment, provide life skills and managing finances, establishing bank accounts, skill-building in computer literacy to support job readiness and workforce development and assist survivors with their long-term goals.





Featured Resource: Safety Net Project - Technology Safety & Privacy Toolkit for Survivors: Teens and Technology

According to a study done by the Pew Research Center, nearly 94 percent of teens, ages 13-17, are online constantly or several times throughout the day. This high rate of usage makes them more susceptible to cyberbullying and abuse of technology use. To address this issue, Safety Net, a project of the National Network to End Domestic Violence (NNEDV), developed resources to educate about safety in technology.

One of the many resources available in their <u>Technology Safety & Privacy Toolkit for Survivors</u> is the <u>Teens and Technology Resource Series</u>, which offers guidance for parents, guardians, or professionals working with teens or young adults dealing with relationship abuse in a digital era and misuse of technology applications.


