Ms. Paceley is an international trainer, counselor, consultant, advocate, activist, and visionary. Ms. Paceley has served on the Board of End Violence Against Women International, serves on the Editorial Board of Sexual Assault Report, and is project advisor to the National Council on Criminal Justice and Disabilities. Since 2000, Ms. Paceley has provided training, consulting, and resource development on a full-time basis on issues related to violence and persons with disabilities.

Teresa Tudor has worked in social services for over 30 years gaining experience in child welfare, disabilities, substance abuse, mental health, and domestic/sexual violence services. In addition to direct client services, much of her work has been focused upon system development, service delivery, and multi-disciplinary collaborative efforts. Ms. Tudor has done extensive training, developed curriculum, written policy, facilitated provider teams, and managed cross-discipline projects.
