April Joint Proclamation Signing / Legislative Resolution Presentation



Over the past two decades, Peace Over Violence, a sexual and domestic violence, intimate partner stalking, child abuse, and youth violence prevention center has championed practicing solidarity and supporting victims by exposing harmful behaviors and attitudes related to sexual violence.

On Denim Day, which takes place on the last Wednesday in April – April 26 this year – we stand in solidarity with sexual assault survivors and victims. Denim Day started as a campaign against sexual assault apologists. In the summer of 1998 in Italy, an 18-year-old girl was raped by her 45-year-old driving instructor. One year later, the perpetrator was released after the court overturned his sentence. He appealed that the girl had had 'consensual' sex with him because she was wearing tight jeans that could have only been taken off with her help. The next day, Italian women showed up in jeans to their workplaces as a way to protest the absurdity of the overturned sentence.



Community Champion: Healing Hearts Crisis Center

Healing from sexual assault is never easy. The journey to recovery from trauma takes time and requires both immediate and long-term services built upon the foundation of understanding that trauma takes many forms, is often overlapping and can be re-experienced in many ways.

The Healing Hearts Crisis Center (HHCC) is Guam's only Rape Crisis Center. As a division of the Guam Behavioral Health and Wellness Center, HHCC exists with the intent to provide survivors of sexual assault with "discrete, immediate and full medical attention".

HHCC incorporates a holistic approach for individuals who may have experienced a sexual assault. Regardless of when the assault or the age, ethnicity, gender or disability of the victim, Healing Hearts offers a supportive, healing atmosphere with caring people to assist them in regaining feelings of safety, control, trust, autonomy and self-esteem. The HHCC team works together to ensure all survivors receive the service they need to begin and sustain the healing process occurred after sexual

assault or abuse. HHCC services include intake assessment and crisis intervention, forensic and multi-disciplinary team interviews, short term case management and linkage to other needed services such as individual and family therapy. HHCC also provides medical services including forensic examinations and collection of forensic evidence, as well as outreach and training to schools, services providers, and the community at large.

Crisis Hotline numbers are 671-647-5351 or 671-647-8833 for all survivors of sexual assault no matter when the assault occurred. If a survivor finds that he or she is facing issues relating to the assault, phone lines are manned 24 hours a day by staff that is willing to help or to listen if the survivor needs to talk.
